Document to sign and return

- Digital files are sold and sent by server or media CD-ROM or DVD-ROM. The delivery fee is the customer's responsibility. Returns must be handled under recorded delivery.
- The photographs issued by the Lyon, museum of Fine Arts – Department of visual resources cannot be sold, retroceded, resold or lent. Duplication of these documents is strictly forbidden.
- The user has sole responsibility with regards to the museum of Fine Arts.

Use

- Sold or hired photographic documents, used for purposes of reproduction or representation require the authorisation of the Lyon, museum of Fine Arts – Department of visual resources.
- Photographs are supplied for one use only. Any other use apart from that originally planned requires new authorisation.
- The user signs a contract of use and commits to send one **document of evidence** of publication to the Lyon, museum of Fine Arts – Department of visual resources. Failure to send this document will result in the payment of a penalty fee.
- The work reproduced must be identified with the artist's name, title, date, followed by its location *Lyon, museum of Fine Arts*, and its *accession number*. The photographer creditline being *Image © Lyon MBA – Photo [name of the photographer]*. If these mention are not included, the Lyon, museum of Fine Arts – Department of visual resources will issue a penalty fee.

Artists's rights: The use of documents is subject to the previous agreement of the author of the work photographed, the authors'association or any rights holder. These rights can be found out through the local authors'association or through the artist directly. These rights concern the artists outside of the public domain. Any violation of these rights is punishable.
